## A WORD FROM OUR CHAIRMAN

Stepping into its eighth year, the Law Association experienced an unprecedented event – a forum was held in which about 70 law students participated to discuss the activities of the Association. Though the forum was received with mixed feelings, it showed that more students are becoming interested in the administration of the Association. The main theme of the forum turned on the merits of the "co-opt method" in organising sub-committees. This method is more convenient, time-saving and probably creates good co-operation within the sub-committees. Most important of all, this method has been the traditional way of doing things in the past because of the usual lack of response of our hardworking students towards the functions of the Association. In the forum, it was queried whether the method is at present still the best way. It has been put that the method may deprive some members of the opportunity to participate as he or she may not be approached, and that he or she may not even learn about the work if there is a lack of publicity. The result is that those members feel they are being neglected. There is substance in such opinions. However, that is not to say that the "co-opt method" is to be done away with. What method is most appropriate in forming sub-committees depends on the magnitude of the work, its nature and the surrounding circumstances. Nevertheless by involving more of us to work together, we can understand each other better and create a greater sense of belonging and unity among us. But all this may well become empty words if we take no action. So spare some of your time and join our functions. With your participation and consensus to support us, the Law Association will march towards the brighter.

In dying, man relinquishes the status and accomplishments he has acquired throughout his lifetime. He becomes nothing more nor less than a man.

After one is dead, what does it matter which side he was on in a war, the "right" side, the "wrong" side, the winner or the loser? What does it matter except to the living?

I suppose the whole thing comes down to one single issue-namely how far are you going to negate the values of this world, or if you are more positive-minded, how far would you go to attribute values to this world's affairs. I mean, to many people, attending university course is phoney enough. And reading law savours all too strong of a petit bourgeois value system-things like a beautiful doll, a big house at Stabley, a big fancy car and what not. To some radicals the mere existence is a phoney thing enough. Camus has a typical existentialist, but in a way picturesque, description of life. Life is a man rolling a stone up a conical hill and then let it go and then rolls it up again and then ... and then. Well, a child is born, he grows, he marries, he struggles for existence and then he returns to dust.

So I say the whole thing is really a matter of value judgment. To me, the chance of meeting old friends and making relatives happy are reasons good enough for me to participate in this phoney occasion.
